The cover should be prominently super scribed with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE". The vehicle will be available for inspection between 3.00 PM to 5.00 PM on 10<sup>th</sup> & 11<sup>th</sup> December, 2009.

3. The quotations received in time will be opened in Room No.374, Udyog Bhavan, New Delhi. The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotation.


4. The auction will be governed by the following conditions:
